THE GOAL OF THE COMPETITION:

- To determine the 2027 Hungarian Championship “B” League title.
- To determine the mixed doubles teams promoted to the 2027 Hungarian Mixed Doubles Curling Championship “A” League.
- To develop and promote curling in Hungary.
- To provide organized competitive opportunities for the member clubs of the Hungarian Curling Federation and for foreign teams as well.

Women’s team: 6 players, 4 players + 1 alternate per game
Men’s team: 6 players, 4 players + 1 alternate per game
Wheelchair team: 6 players, 4 players (minimum 1 player from each gender) + 1 alternate per game

TIME AND METHOD OF ENTRY:

Deadline of entry: 16:00 on 5th October 2026
Entry fee: 250 EUR

Entry method: Entries must be submitted to the HCF via the entry form available on the HCF website at the following link, by the entry deadline:

A valid entry requires proof of payment of the entry fee (bank transfer confirmation) to be attached to the entry form.

Payment method: The entry fee must be paid by bank transfer to the HCF bank account before the entry deadline.

FINAL SCHEDULE AND TECHNICAL SUMMARY:

The final schedule and technical summary will be sent electronically to the team leaders and will also be available on the HCF website on the [competition information page](#) no later than **4th November 2026**. The OC reserves the right to deviate from this competition announcement or the published schedule in exceptional and sufficiently justified circumstances, while complying with the World Curling rules.

FORMAT OF THE COMPETITION:

The format of the competition will depend on the number of registered mixed doubles teams:

- **8 or fewer registered teams:** the competition will be played in a single round robin format. The top 4 mixed doubles teams in the round robin will advance to the playoffs.
- **9 to 12 registered teams:** the competition will be played in two groups, each using a single round robin format. The top 3 mixed doubles teams from each group will advance to the playoffs.
- **More than 12 registered teams:** depending on the number of entries, some teams may be seeded based on the ranking list and may enter the competition at a later stage. The preliminary round will be played in multiple groups, based on the final number of registered teams. The number of teams advancing to the playoffs will be determined according to the number of groups.

The OC reserves the right to modify the schedule in order to ensure the complete separation of the playoff stages for the Hungarian and International (Open) categories.

PRIZES:

The podium finishers will be awarded separately in the International (Open) and Hungarian categories. The International (Open) category includes:

- 1st place: medal
- 2nd place: medal
- 3rd place: medal

The medals will be presented at the venue immediately following the final game.

ELIGIBILITY:

Hungarian mixed doubles teams: Please refer to the Hungarian competition announcement document for the eligibility requirements applicable to Hungarian mixed doubles teams.

Non-Hungarian participants: foreign players, mixed doubles teams and wheelchair mixed doubles teams are permitted to participate in the Hungarian Mixed Doubles Curling Championship ‘C’ league, provided that they:

- have submitted their entry and paid the entry fee by the entry deadline;
- comply with the World Curling rules and regulations and the rules of the competition;
- comply with the principle of fair play and do not disrupt the fair and orderly conduct of the competition through their behaviour.

Based on the final standings of the Hungarian Curling Championship “B” League, a foreign or wheelchair teams may not earn the right to participate in the Hungarian Curling Championship “A” League.

RULES OF THE COMPETITION:

- Technical summary will contain the rules of the competition.
- Only brushes approved by the World Curling may be used during the championship.
- The OC reserves the right to deviate from these rules in extraordinary cases.
- **During the competition, the applicable World Curling rules will apply.**
- An e-mail sent to the Head of the OC shall be considered an official request or protest regarding the competition. The Head of the OC shall decide on the requests received and any disputes arising, in consultation with the members of the OC. The Head of the OC will inform the parties concerned of the decision in writing.
- Players who do not have appropriate curling shoes may rent sliders from the Curling Club free of charge. They must wear clean training shoes.

UNIFORM POLICY:

There is no requirement for team members to wear matching uniforms during the games.

PROTESTS AND APPEALS:

Protests and appeals will be handled in accordance with the HCF Protests and Appeals Regulations currently in force. Note that this document is only available in Hungarian.

OTHER RULES AND GUIDELINES:

- If a team requests a change to the competition schedule, the team shall be responsible for any additional costs incurred.
- If a team fails to appear for a scheduled game, the non-offending team may be offered 75 minutes of practice time. The OC must be informed whether or not the team wishes to take this opportunity. The practice time will start at the scheduled game time.
- The first stone of an end may not be delivered before the end of the designated break between ends. The teams have 10 seconds after the end of the break to deliver the first stone of the next end. After this 10-second period, the officials will start the team's thinking time. The same procedure applies following the half-time break.
- The teams must sign the game report after the completion of the game.
- In the event of unsportsmanlike behaviour, the official may issue a warning or exclude a team from further participation in the competition. Unsportsmanlike conduct may also result in Ethics and Disciplinary proceedings.

ICE CARE:

- The players are asked to keep the ice clean. Please enter the ice only in clean shoes and avoid leaving your hands, knees or other parts of your body on the ice for an extended period of time, particularly after delivery.

OTHERS:

- Each player competes at their own risk.
- Teams and the players must follow the “house rules” of the Curling Club.
- The Hungarian Curling Federation considers environmental protection and sustainability important aspects of the organization of the competition. We kindly ask all participants, supporters, and accompanying persons to minimize waste production throughout the event. Where available, please use recycling waste bins instead of general waste containers. We encourage everyone to use public transportation, share car rides, and help keep the competition venue clean.

2027 Hungarian Curling Championship “B” league

- If a team fails to show up for a game, withdraws from the competition, or fails to provide an official justification, a mandatory payment of 40 EUR will be required. In case of injury, teams have 5 working days to submit a medical report to the OC in digital form (scanned or photographed).
